CPHI FRANKFURT : ANJAC HEALTH & BEAUTY PRESENTS TWO NEW INNOVATIVE TECHNOLOGIES AND CONFIRMS ITS AMBITIONS IN THE HEALTHCARE AND PHARMA SECTOR

ANJAC Health & Beauty, a French family-owned industrial group and one of the leaders in formulation, manufacturing, and packaging of products for the health, beauty, and dietary supplements sectors, is strengthening its commitment to the healthcare industry. On the occasion of the CPHI Frankfurt trade show, the group and its subsidiaries are announcing several major investments in the fields of respiratory and ENT health, dermatology, women's health, as well as nutrition and dietary supplements.

Health, a strategic growth driver for the ANJAC Group

ANJAC Group's health-pharma business is currently driven by eight of its subsidiaries: Chemineau, Feltor, Cosmetix West, Pillar5 Pharma, Eurowipes, Shadeline, Innovi, and Roval. This activity represents 30% of the Group's revenue and constitutes a key pillar of its growth strategy, which may be further supported by future acquisitions in Europe in the fields of nutrition and dietary supplements.

The CPHI Frankfurt trade show, in which ANJAC is participating, provides an opportunity to reaffirm its ambitions in four key strategic areas in particular :

- **ENT**, with recognized expertise in local solutions (sprays, mouthwashes...) and major innovations in the respiratory field ;
- **Dermatology**, with a comprehensive approach covering prevention, management of acute and chronic conditions, medical treatments, and dermocosmetics as a therapeutic adjunct ;
- **Women's health**, with tailored solutions for every stage of life, addressing hormonal variations and overall well-being ;
- **Nutrition and dietary supplements**, promoting wellness and healthy aging, with a preventive approach aimed at supporting overall health.

Two proprietary innovative technologies unveiled at CPHI

True to its DNA as an innovative player in the health and beauty industries, ANJAC is taking advantage of the CPHI event to announce the launch of two new technologies : **Cicalyte** and **Emulpro**, both of which are currently patent pending.

Cicalyte is an innovative electrolyte solution inspired by the composition of extracellular fluid, with anti-inflammatory and healing properties. This technology opens new perspectives in the management of rhinosinus and bronchial conditions, such as nasopharyngitis, sinusitis, allergies, or post-operative care, by restoring mucosal functionality.

As a true bioactive agent, **Cicalyte** helps restore mucosal health and enhances the effectiveness of local treatments. It offers a superior alternative to commonly used saline (NaCl) or purified water solutions in pharmaceutical formulations, which can weaken the nasal mucosa and delay healing. **Cicalyte** can be incorporated into any product administered via the nasal or bronchial route, including hygiene solutions or local treatments containing vasoconstrictors, corticosteroids, or antihistamines.



Emulpro, is an emulsion technology designed to deliver optimal penetration through its micro-droplet structure. Ultra-tolerant and microbiome-friendly, it enables the incorporation of both pharmaceutical and cosmetic active ingredients while minimizing the risk of skin barrier disruption, irritation, dryness, or microbiome imbalance.

Adaptable to multiple topical administration routes (cutaneous, mucosal, oral, nasal) and a variety of textures, Emulpro paves the way for new treatments in dermatology (atopic skin, acne, dermatitis, sensitive areas), optocosmetics (eye contour care), and more broadly in women's health (vulvar dryness, intimate discomfort). A turnkey **Emulpro–Atopic Dermatitis** application is already available.
