### **2. General terms and conditions of use of the website and the services offered**

In Safari: Click on the menu pictogram (symbolised by a cog) at the top right of the browser. Select Settings. Click Show advanced settings. In the "Privacy" section, click Content settings. In the "Cookies" section, you can block cookies.

In Chrome: Click on the menu pictogram (symbolized by three horizontal lines) at the top right of the browser. Select Settings. Click Show advanced settings. In the "Privacy" section, click preferences. In the "Privacy" tab, you can block cookies.

## **9. Applicable law and jurisdiction**

Any dispute in relation to the use of the anjac.com website is subject to French law. Exclusive jurisdiction is assigned to the competent courts of Paris.
